All purchases are final, and the purchaser must notify the Museum in writing 24 hours prior to the sale to revoke the purchase proxy. The Museum reserves the right to carry out the sales contract via a secured credit card on file if payment arrangements have not been made by the following Wednesday after the sale. Any incomplete payments will result in revoke purchasing privileges in all future Museum art sales. Visa, MasterCard, American Express and Discover are accepted and subject to a 3% credit card fee. Ownership of piece transfers to the buyer at time of purchase. Piece will stay on display in the exhibition until October 12, 2025. Shipment will then be arranged with the buyer and buyer is responsible for all shipping fees. Buyers shipping/picking up artwork in the state of Oklahoma must pay Oklahoma state and local sales tax (8.625%).
